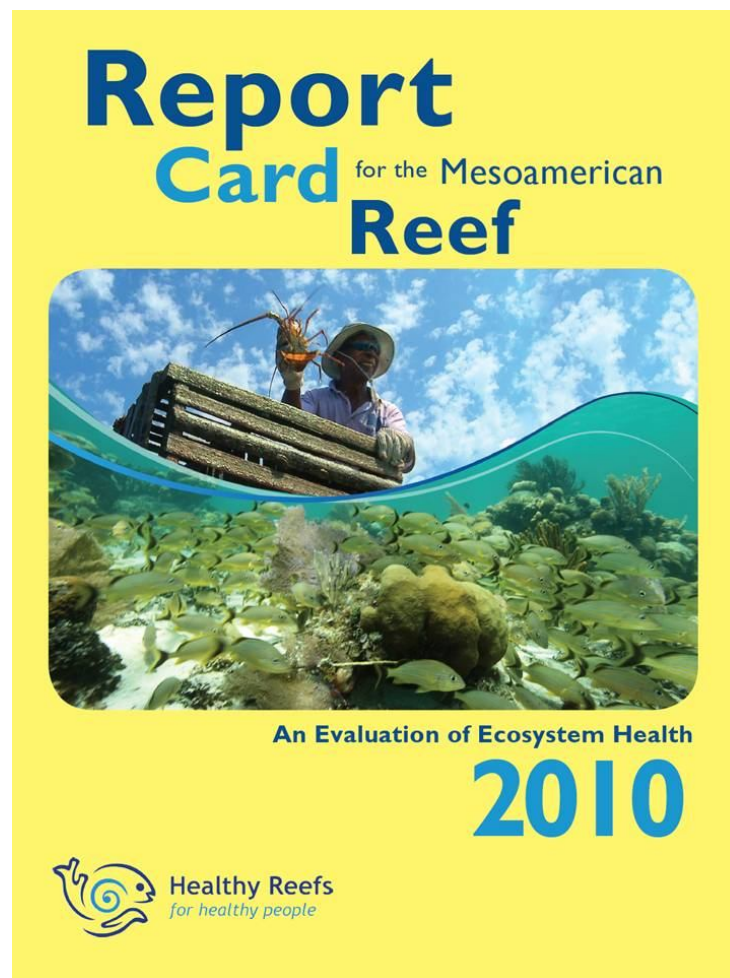

Changes shown in **bold** letters.

Page 3: Taking Stock

First column, last paragraph: “with four indicators) found an alarming **30%** of reefs in ‘critical’ condition, **40%** in ‘poor’, **21%** in ‘fair’, **8%** in ‘good’ and 1% ‘very good’ condition.

Second column, first paragraph: “were over **40 cm** (16 inches) long and sharks are now largely”

Page 8: Shifting baselines and reef health

Last paragraph, missing reference number 2: “bleaching event.² Archeological”

Page 14: Climate change: Already impacting our reef

First column, first paragraph: “productivity is **declining.**”¹

Page 16: Marine protected areas

In the references numbers, the second #1 (“unprotected reefs.¹”) should be #3 reference.

Note on main map (page 5-6): The actual color of the four ‘good’ sites for southern Mexico, located at the top of page 6 is light green, but the sites are very close and printed mostly on top of each other that it appears like dark green.
